EL REY CHICKEN RZR GIVEAWAY

OFFICIAL RULES & TERMS OF PARTICIPATION

Sponsor: El Rey Chicken LLC, Colorado

Promotion Period: Friday, May 29, 2026 through Friday, October 25, 2026
(approximately 120 days)

Prize: One (1) ATV, approximate retail value \$24,000 (“Prize”)

No Purchase Necessary: See Section 4 for free alternative method of entry

Geographic Scope: Open to residents of the State of Colorado only

1. SPONSOR

El Rey Chicken LLC (“Sponsor”), a Colorado limited liability company, is the sole sponsor of this sweepstakes promotion (the “Promotion”). The Promotion is not sponsored, endorsed, administered by, or associated with any social media platform, including but not limited to Instagram, Facebook, or TikTok.

2. ELIGIBILITY

The Promotion is open to natural persons who, at the time of entry:

- Are eighteen (18) years of age or older;
- Are physically located within the State of Colorado at the time of entry;
- Are not employees, officers, directors, agents, or representatives of El Rey Chicken LLC, or members of their immediate families (spouse, parent, child, sibling, or household member); and
- Have not been disqualified pursuant to these Official Rules.

No citizenship or immigration status requirement applies. Void where prohibited by law.

3. PROMOTION PERIOD

The Promotion begins at 12:00 AM Mountain Time on Friday, May 29, 2026 and ends at 11:59 PM Mountain Time on Friday, September 25, 2026 (“Promotion Period”). Entries submitted before or after the Promotion Period will not be eligible. Sponsor’s clock is the official timekeeping device for this Promotion.

4. HOW TO ENTER

4.1 Purchase-Based Entry (Method 1)

During the Promotion Period, an eligible participant may receive one (1) entry for each qualifying combo meal purchase made at El Rey Chicken’s food truck (“Qualifying Purchase”). At the time of purchase, the participant will be directed to the official digital entry form via the QR code displayed at the food truck. To complete a purchase-based entry, the participant submits the digital entry form and indicates their Qualifying Purchase as directed by El Rey Chicken staff. Incomplete entries are void.

A participant earns one (1) entry per Qualifying Purchase, and there is no limit on the number of entries a participant may earn through separate Qualifying Purchases during the Promotion Period. Each entry must correspond to a separate Qualifying Purchase.

4.2 No Purchase Necessary – Alternate Method of Entry (AMOE)

NO PURCHASE IS NECESSARY TO ENTER OR WIN. Making a purchase does not improve your odds of winning.

To enter without a purchase, an eligible participant may complete the official AMOE entry form by:

- Scanning the official QR code posted at the El Rey Chicken food truck location; or
- Accessing the official digital entry form through the link posted on El Rey Chicken’s official social media profiles, available 24 hours a day during the Promotion Period.

The digital entry form requires the following information: full legal name, phone number, email address, and mailing address. Each completed free entry (AMOE) submission constitutes one (1) entry. A participant may submit a maximum of one (1) free entry for the entire Promotion Period. This limit applies only to free (no-purchase) entries; participants who make Qualifying Purchases may earn multiple entries as described in Section 4.1. Any participant who submits more than one (1) free entry will have all excess free entries disqualified. If a participant who has submitted more free entries than permitted is selected as the potential winner, that participant will be disqualified and an alternate winner will be selected in accordance with Section 7.

Mechanically reproduced, automated, or bulk entries are void. Entries submitted by third parties on behalf of another individual are void. Sponsor is not responsible for lost, late, incomplete, or misdirected entries.

5. ODDS OF WINNING

Odds of winning depend on the total number of eligible entries received during the Promotion Period. The more entries received, the lower the odds of winning.

6. PRIZE

6.1 Prize Description

One (1) grand prize winner will receive one (1) all-terrain vehicle (ATV) with an approximate retail value (ARV) of \$24,000 (“Prize”). The specific year, make, and model of the ATV will be determined by Sponsor prior to the drawing and will be disclosed to entrants at least fourteen (14) days before the drawing date. No cash alternative or prize substitution is permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable for any reason.

6.2 Prize Conditions

To claim the Prize, the winner must:

- Respond to notification within five (5) calendar days of first notification attempt;
- Claim the Prize within thirty (30) calendar days of notification;
- Possess a valid, current driver’s license or state-issued ID at the time of prize claim;
- Execute an Affidavit of Eligibility and Liability/Publicity Release (where permitted by law) within ten (10) calendar days of receipt;
- Complete and return IRS Form W-9 (or applicable equivalent) prior to prize transfer; and
- Accept transfer of the Polaris RZR with a clean title and Manufacturer’s Statement of Origin (MSO), free and clear of liens.

Failure to satisfy any Prize condition within the required timeframe may result in forfeiture of the Prize and selection of an alternate winner.

6.3 Taxes

The Prize constitutes taxable income to the winner under applicable federal and Colorado state law. The ARV of the Prize will be reported to the IRS on Form 1099-MISC if required by law. Winner is solely responsible for payment of all applicable federal, state, and local taxes on the Prize. El Rey Chicken LLC is not responsible for any tax liability of the winner. Winner may be required to provide a valid Social Security Number or Individual Taxpayer Identification Number (ITIN) prior to prize transfer for tax reporting purposes.

Note to Winner: On a Polaris RZR with an ARV of approximately \$22,999, federal income tax liability will depend on your individual tax bracket. As a rough estimate, winners in the 22–24% federal bracket may owe approximately \$5,060–\$5,520 in federal income tax, plus applicable Colorado state income tax (currently a flat 4.4%), which may add approximately \$1,012. Winner should consult a tax professional for personalized guidance.

7. WINNER SELECTION & NOTIFICATION

7.1 Drawing

On or about Friday, October 30, 2026, Sponsor will select one (1) potential winner at random from all eligible entries received through the official digital entry system during the Promotion Period.

Prior to selection, Sponsor will review and remove any duplicate or disqualified entries, including excess free entries as described in Section 4.2. The random selection will be made using a verifiably random method (such as a random number generator applied to the numbered list of eligible entries) and will be witnessed by at least one (1) independent adult witness who is not an employee or family member of Sponsor. The selection process will be documented (video recording or written attestation by witness) and records retained for a minimum of one (1) year following the conclusion of the Promotion.

The winner will be selected at random from the consolidated pool of all eligible purchase-based and free entries after removal of any duplicate or disqualified entries.

7.2 Notification

The potential winner will be notified by phone and/or email within three (3) business days of the drawing. If a potential winner cannot be reached within five (5) calendar days of first notification attempt, or if the potential winner fails to satisfy any eligibility requirement or Prize condition, the potential winner will be disqualified and an alternate winner will be selected from the remaining eligible entries. This process will continue until a confirmed winner is identified.

7.3 Winner Announcement

The confirmed winner's name and general location (city/state) may be announced on El Rey Chicken's social media platforms, subject to applicable law and winner's consent. Winner may opt out of public announcement by notifying Sponsor in writing within five (5) days of prize confirmation.

8. GENERAL CONDITIONS

- Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, violates these Official Rules, or acts in an unsportsmanlike or disruptive manner.
- Sponsor reserves the right to cancel, suspend, or modify the Promotion if fraud, technical failure, or any other factor impairs the integrity of the Promotion, as determined by Sponsor in its sole discretion.
- By entering, each participant agrees to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters relating to the Promotion.
- The Promotion is subject to all applicable federal, state, and local laws and regulations.
- No transfer, assignment, or substitution of an entry is permitted.

9. RELEASE & LIMITATION OF LIABILITY

By participating, entrants release and hold harmless El Rey Chicken LLC, and its members, managers, employees, agents, and successors from any and all liability for any injury, loss, or damage of any kind arising from participation in the Promotion or acceptance, possession, or use of the Prize, including but not limited to personal injury, property damage, or death. Sponsor's total liability shall not exceed the ARV of the Prize.

10. DISPUTE RESOLUTION & GOVERNING LAW

These Official Rules shall be governed by and construed in accordance with the laws of the State of Colorado, without regard to conflict-of-law principles. Any dispute arising from or relating to the Promotion shall be resolved exclusively in the state or federal courts located in El Paso County, Colorado. Entrants waive any right to a jury trial with respect to any such dispute.

11. PRIVACY

Personal information collected in connection with this Promotion will be used solely to administer the Promotion and notify the winner, and will not be sold, rented, or disclosed to third parties except as required by law or as necessary to administer the Prize. Sponsor's collection and use of personal information is subject to applicable Colorado privacy law.

12. VOID WHERE PROHIBITED

This Promotion is void outside the State of Colorado and wherever prohibited or restricted by law. All federal, state, and local regulations apply.
